1. Call to order Workshop. Welcome Citizens and Visitors.

 Mayor Richard Hein called the workshop to order at 6:01pm. Members present: Mayor Richard Hein, Mayor Pro Tem Billy Robbins, Alderman Jeremy Rice, Alderman Tom Ray, Alderman Rob Hendrick and Alderman Jim Story. Employees present: City Manager Drew Brassfield, City Secretary Christina Athey, Public Works Director Brent Sheets, and Police Chief Bobby Chapmon.

2. Workshop on Water Rates and Related Information.

- Mayor Richard Hein presented the Water Improvement and Street Plan. He requested that the plan be posted on the website as soon as possible.
- Mayor Richard Hein presented the water rate spreadsheet. After discussion the council
 proposed changing the Base Rates to \$40 for inside city limits and \$45 for outside city limits.
 The 2021-2022 budget planning will reflect this change going into budget workshops.
 - Research needs to be done for notifying the public of water rate changes.

By State law, the City Council is not allowed to respond to comments and questions asked of them by an open forum speaker. Any response by a member of the City Council must be limited to referring the matter to staff, a statement of specific factual information/ recitation of existing policy, or a proposal to place the subject on a future agenda for a future City Council meeting.

 Susan B. spoke about roads and standing water in the city. Mayor asked that she contact City Hall to address issues.
