- g) Discuss and take action on adoption of Ordinance 585, levying taxes for the Maintenance and Operations fund and providing for the Interest and Sinking fund for FY 2021.
  - Mayor Pro Tem Billy Robbins made a motion to adopt Ordinance 585, levying taxes for M&O and I&S fund for FY 2021 with a total tax rate of 0.682051 per \$100.
